## In Memoriam



Our group has lost two very special members recently. **Yonghyo Moon** and **Zella Morgan** were both true artists and genuine people who will be greatly missed.

**Zella**, 87, died February 7th following a short illness. She had joined SBA early on and was an exhibitor at the first show held at Jakeman Hall in late 1995. She originally had met Elizabeth Shore when she signed up for a painting class that Elizabeth was offering one summer in Ocean Park.

While raising her family, she worked in acrylic painting & pen and ink drawing. Later she designed unique note cards, prints and hand-painted porcelain. She also did watercolor and oil landscapes, portraits and still lifes. She is remembered as a soft-spoken and very sweet person

**Yonghyo**, 80, died May 2nd after a difficult battle with cancer. A practicing Buddhist and an engineer by trade, she was a very successful painter who sold her work in many

venues including a gallery in Korea. She was active in the SBA for the past 5 years and worked in water-based oils and pastels. Her landscapes were very photographic and realistic. She had just become a grandmother weeks before her passing and was happy that she had been able to meet her new grandchild. Her husband kindly donated her art brushes and supplies to the SBA in her memory.

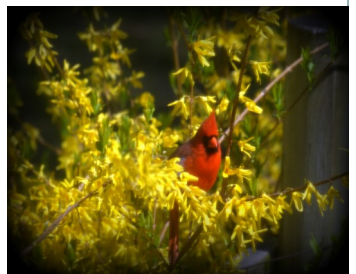
I decided to include the Cardinal (see photos) and share our story in this month's column—thank you for humoring me...

## **Saco Bay Artists Summer Show Guidelines**

**GENERAL:** Dates for 2012 are Wednesday, July 4; Saturday, August 4; and Saturday, September 1. Shows will be held from 9 AM to 4 PM on the Ocean Park Library lawn on Temple Avenue between West Grand and Seaside Avenues. Artists can set up starting at 6:30 AM and must remain set up until 4 PM.

**FIRST TIME EXHIBITORS:** If you are a first time exhibitor for the show, you must send in with your application a CD or 3-5 photographs of your work for jurying purposes.

**SPECIAL REQUESTS:** If you desire a particular space, please note your preference at the bottom of the application in the "Special Requests" section and efforts will be made to accommodate you. Space assignments will be emailed or mailed one week prior to the show.

**PARKING:** Since parking is limited, plan to arrive early and to stay until breakdown at 4PM. A parking pass will be provided the morning of the show.

**DISPLAYS/TENTS:** Artists must supply their own displays, which must be placed facing in and two feet from your closest neighbor's spot. Any tent and/or display cannot exceed 10 x 10 feet unless additional space is rented. All artists are to stay in their assigned spaces and if their displays exceed these specifications they will be asked to immediately change their display to fit.

**ARTWORK DISPLAYED:** Due to the relationship we have with the Ocean Park Association, we ask that no paintings of nudes be displayed. All work that is shown must be original works of fine art and not infringe on the copyright of others. **This is a fine art show and no crafts are permitted.** Reproductions of your originals are allowed and encouraged. Saco Bay Artists reserves the right to refuse any work not following the above guidelines. Saco Bay Artists reserves the right to limit the number and type of media being displayed.

**FEES:** Fees are for each artist participating in the show, regardless of whether one shares a tent or has their own tent. Every artist showing work must register, be juried in and pay the entry fee.

Entry fee for Saco Bay Artist members: \$50

Entry fee for Non-members: \$80

**RAIN DATES/CANCELLATIONS:** Shows will be held rain or shine. All show fees are non-refundable.

**DUE DATE:** Applications for all three shows must be postmarked by **June 1, 2012**. Applications received after that date will be placed on a waiting list. If there are spaces still available for each show, assignments will be made on a first come/first serve basis.
